INSTRUCTIONS TO STUDENTS

- 1. Details once uploaded cannot be changed under any circumstances. So extreme care should be taken while entering the data.
- 2. There is no upper limit for the number of scholarships that a student can apply.
- 3. No students are allowed to avail multiple scholarships other than Hindi Scholarship and Snehapoorvam Scholarship.
- 4. If a student is selected for more than one scholarship, he/she must select one scholarship and has to cancel all other except Hindi Scholarship and Snehapoorvam Scholarship.
- 5. Students have to notice the announcements regarding scholarship through the public address system/scholarship websites /News papers and act accordingly to avoid technical difficulties.
- 6. Students are directed to submit applications and related documents demanded by college office/scholarship wing in time. The college is not responsible for non availability or cancellation of scholarship due to the delayed or non submission of documents/applications.
- All scholarships will be disbursed only through bank account of the 7. students. So, the students are directed to open an account with any one of the following banks:
 - a. SBI.
 - **b.** Federal Bank
 - c. South indian Banks
 - d. Other Nationalized Bank.
- 8. Application for all scholarship except MGS (Muslim Girls Scholarship) and Snehapoorvam must be submitted by the student during the first vear degree program on time.
- 9. Selected students should renew their scholarship in the succeeding years (Up to final PG)
- All aspirants should have a valid AADHAR. 10.
- Those who are having at least 75% of attendance are eligible for 11. renewal.
- 12. Students are advised to go through the website concerned after the notification of each scholarship. There may be slight variations in the procedure given in the handbook.

POST MATRIC **SCHOLARSHIP**

BACKGROUND

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It declared that a post-matric scholarship scheme for meritorious students form minority communities would be implemented.

OBJECTIVE

The objective of the scheme is to award scholarship to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

SCOPE

The scholarship is awarded for studies in India in a government or private higher secondary school/college/university, including such residential institutes of the Government and eligible private institutes selected and notified in a transparent manner by the state Government/ Union Territory Administration concerned. It will also cover technical and vocational programmes in Industrial Training Institutes/ Industrial Training Centres affiliated with the National Council for Vocational Training (NCVT) of classes XI and XII level.

DISTRIBUTION

Muslim, Christian, Sikh, Buddhist, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act. 1992. The distribution of scholarship among the States/Union Territories will be made on the basis of population of the above notified minorities in the States / Union Territories of Census 2001.

EAR MARKING FOR GIRL STUDENTS

30% of scholarship will be earmarked for girl students. In the absence of sufficient number of eligible girl students, the balance earmarked scholarships will be awarded to eligible boy students.

DURATION

Scholarship will be provided for the entire programme. However, maintenance allowance will be given for a period not exceeding 10 months only in an academic year.

RATE OF SCHOLARSHIP

Actual financial assistance will be provided for admission & course / allowance as given below subject to a tuition fee and maintenance maximum ceiling indicated against item concerned.

IMPLEMENTING AGENCIES

The scheme will be implemented through the State Government/ Union Territory Administration.

CONDITIONS FOR SCHOLARSHIP

- Scholarship will be awarded to the students who have secured not less 1. than 50% of marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian from all sources does not exceed Rs. 2.00 lakh. Unlike scholarship for SC and ST, number of scholarships for minorities is limited and hence preference for selection has been laid down. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.
- 2. The award will be discontinued if a student fails to secure 50% marks or equivalent grade in the previous final examination. Scholarship will not be awarded for more than the normal period of time taken to obtain Certificate / Degree / M. Phil Degree / Doctorate Degree.
- Scholarship will not be given to more than two students in a family. 3.
- 4. The students should be regular in attendance for which the yardstick will be decided by the competent authority of the school/college/ university.
- 5. Migration of students from one institution to another would not normally be allowed during the course of the academic year except under the exceptional circumstances and in the interest of the student's academic career.
- If a student violates any other term and condition of the scholarship, the 6. scholarship may be suspended or cancelled. The State Government /Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.
- 7. If a student is found to have obtained a scholarship by false statement/Certificates, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid shall be recovered, at the

discretion for the concerned State Government/Union Territory Administration.

- 8 Course fee/ tuition fee and maintenance allowed will be credited directly to the students' bank account.
- The State Government/ Union Territory Administration will maintain a 9. separate account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.
- 10. The student obtaining benefits under this scholarship scheme shall not be allowed to avail the benefits under any other scholarship scheme implemented by State Government / UT Administration, for the same purpose.
- 11. The State Government /Union Territory administration shall constitute a Committee of the departments implementing such scholarship schemes to ensure that the students form the minority community, who may also belong to SC/ST/OBC category do not avail scholarship from other sources for the same purpose and avail only from one source.
- 12. The regulations can be changed at any time at the discretion of the Government of India.
- 13. The concerned State Government/Union Territory administration will be responsible for processing and scrutinizing the applications submitted by the students (as per the work flow opted) and send the proposal of eligible students online to this Ministry for sanction of the scholarships as per timelines.

RENEWALOFSCHOLARSHIP

The scholarship, once awarded, may be renewed during the next academic year of the programme on the production of certificate that the student has secured 50% of marks in the examination.

ANNOUNCEMENT

The scheme will be announced by the State Government/Union Territory Administration concerned well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media.

EVALUATION

The monitoring of the financial and physical performance of the scheme will be done by assigning evaluation /impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India.

PROCEDURE FOR APPLYING

- The scheme is implemented through National Scholarship 1. Portal (NSP). It is mandatory for all students to apply online on the website of this Ministry i.e. www. scholarships.gov.in

 - Fee Receipt of current programme year(Mandatory) g.
 - Proof of Bank Account in the name of student (Mandatory) h.
 - Aadhaar Card (Optional) i.
 - Residential Certificate (Mandatory) i.



CENTRAL SECTOR SCHOLARSHIP

OBJECTIVE

To provide financial assistance to meritorious students from low income families to meet a part of their day-to-day expenses while pursuing higher studies.

SCOPE

The scholarships are awarded on the basis of the results of Senior Secondary Examination. 82,000 fresh scholarships per annum (41,000 for boys and 41,000 for girls) are awarded for pursuing graduate /postgraduate studies in colleges and universities and for professional courses, such as Medical, Engineering etc.

ALLOCATIONS OF SCHOLARSHIPS

The total number of scholarship are divided amongst the State

Education Boards based on the states population in the age group of 18-25 years, after segregating share of CBSE and ICSE on the basis of number of students passing out from various Boards in the country. 50% of the scholarship is earmarked for girls. The number of scholarship allotted to a State Education Board is distributed amongst pass outs of the Science, Commerce and Humanities streams in the ratio 3:2:1. In case of shortfall in the number of applications, the scholarship slots could be interchanged.

ELIGIBILITY

Students who are above 80th percentile of successful candidates in the relevant stream from the respective Board of Examination in Class XII of 10+2 pattern or equivalent and pursing regular programme (not correspondence or distance mode) in Colleges/ Institutions recognized by All India Council of Technical Education, UGC Act 1956, Medical Council of India, Dental Council of India and respective regulatory authorities and not availing benefit of any other scholarship scheme including State run scholarship schemes / Fee waiver and reimbursement scheme are eligible under the scheme. Students pursuing Diploma courses are not eligible under the scheme.

RESERVATION

Students belonging to reserved categories/weaker sections/minorities are eligible on the basis of merit, subject to Central Reservation Policy and internal earmarking. Reservations for the various Categories are as follows: Scheduled Castes (SCs) 15%, Scheduled Tribes (STs) 7.5%, Other Backward Classes (OBCs) 27% and horizontally 5% for Physically Handicapped / Persons (s) with Disabilities (PwDs) in all the categories.

ANNOUNCEMENT OF THE SCHEME AND

SELECTION PROCEDURE

- 1. National Scholarship Portal (NSP) www.scholarships.gov.in will be opened for online application in the month of June-July every year.
- 2. Class XII pass out students of the current academic Year, who are above 80th percentile of the respective State Education Boards (SEBs) are eligible under the scheme and can apply on National Scholarship Portal (www. scholarship.gov. in), before the cut-off date. Physical application would not be accepted.
- 3. The online applications would be verified at two levels:
 - i. By the Institute where the student is studying.

- ii. By the respective State Education Board.
- 4. Applicant is required to submit requisite documents, such as Class 12th mark sheet. Income Certificate to the Institute.
- 5. Application which is not verified either by the institute or by the concerned State Education Board will be treated as invalid.
- 6. Merit list as per the State allocated quota would be generated from the verified application.

RATE OF SCHOLARSHIPS

The rate of scholarship is Rs. 10,000/- Per annum at Graduation level for first three years of college and university courses and Rs. 20,000/per annum at Post Graduation level. Students pursuing professional courses, in case, where the duration of course is five (5) Years / integrated course would get Rs. 20000/- per annum in the 4th and 5th year. However, students pursuing technical programmes such as B.Tech., B.Engg., would get scholarship upto graduation level.

PARENTAL INCOME CEILING

The parental / family income ceiling is Rs. 6 lakh per annum for all categories under the scheme.

DURATION OF SCHOLARSHIPS AND ITS RENEWAL

A student will be eligible for the scholarship for a total duration not exceeding 5 years. A scholarship under the scheme is renewable on year basis to year up to Post Graduate level in the same stream (except for the students pursuing technical courses leading to degree at graduation level). The renewal will depend on:

- Securing 50% or more marks in the preceding examination i.
- ii. 75% attendance
- iii. Not indulged in ragging activities

If a scholar is unable to appear in the annual examination owing to illness and or on account of any unforeseen event, the award may be renewed for the next academic year on submission of medical certificate and other proof to satisfy the Head of the institution who will certify that the student would have passed with 50% or more marks or equivalent Grade Point Average. had he/she appeared for the examination.

A scholar would be allowed to continue/renew his/her scholarship if he/she changes the course of study to a stream not offered by his school board in Class XII (e.g. Law, Fashion Technology, etc.). Students changing their college / institute of study would be allowed to continue/renew the scholarship provided the programme of study and the institution is recognized.

For receiving scholarship benefit under Centrel Sector scheme of Scholarship for College and University students, an individual shall furnish proof of possession of Aadhaar or undergo Aadhaar authentication. Till the time Aadhaar is assigned to the individual, following alternative identifiers can be used:

- i. Aadhaar Enrolment ID slip
- ii. Application made for Aadhaar enrolment
- iii. Voter identity card
- iv. Permanent Accounting Number
- v. Passport
- vi. Driving Licence
- vii. Certificate of identity having photo issued by a Gazetted Officer or a Tahsildar on an official letterhead.
- viii. Identity Card issued by the college or institute or university.
- ix. Any other document with photos specified by the State Government.

Further, the students are required to have the bank accounts opened, especially in their name for availing the benefits under the scheme. The scholarship will be disbursed directly into the bank accounts of the beneficiaries through Direct Benefit Transfer (DBT) Mode. The student can track their payment status from the template "Know Your Ppayment" in the public Financial Management System (PFMS) Portal [https://pfms.nic.in/Users/Login Details/Login.aspx] either by indicating Aadhaar number or bank account number.

PROCEDURE FOR RENEWAL OF SCHOLARSHIP

For students of Academic year 2015 and onwards:

Students who have passed Class XII and have received fresh / renewal scholarship through the National Scholarship Portal (NSP) must apply online in the National Scholarship Portal (www.cholarships.gov. in) for the revewal scholarships.

For students of Academic Year prior to 2015:

Students who have passed Class XII prior 2015 are required to obtain the renewal application blank form the respective State Education Boards and submit the same duly certified from their respective institutions which is required to certify:

a. That the student has secured 50% or more marks in the previous examination.

- That the student has 75% attendance b.
- That the student is not involved any ragging activities. C.

Renewal applications sent direct to the Ministry of Human Resource Development shall not be accepted.

- Should have scored 50% or above in the qualifying Examination.
- Family annual income should no exceed 1 Lakh. For Exemption of annual income based on merit, please see the notification.

PRATHIBHA SCHOLARSHIP **PROGRAMME**

The programme provides scholarship for students who have qualified meritoriously in the Higher Secondary Examination from Kerala for pursuing Degree/Post Graduate programmes in Basic/Natural Science in Institutions/Universities in India.

ELIGIBILITY CONDITIONS

- Students who have qualified with minimum aggregate marks of 95%. or equivalent grade for all subjects and minimum 95% aggregate marks or equivalent grade for all science subjects for the Higher secondary Board Examination.
- Such students should also have secured admission for B.Sc/Integrated M.Sc courses in Basic or Natural Science in any of the Institutions or Universities in India.
 - (For SC/ST reservation category, the minimum eligibility is stipulated

to minimum marks of 90% or equivalent grade for all subjects in total and minimum 90% marks or equivalent grade for all science subjects in total in the Higher Secondary Board Eexamination.

RATE OF SCHOLARSHIP

B.Sc Degree Programme /first 3 years of Integrated M.Sc course.

1st Year - Rs.12,000/-2nd Year - Rs. 18,000/-3rd Year - Rs. 24.000/-

RENEWAL OF THE SCHOLARSHIP

The Scholarship will be released initially for the first year only and is renewable in the subsequent years of the course subject to successful completion of the previous year's examination with minimum 60% aggregate marks in all subjects. In case of tie in the total marks for science subjects, ranking is made based on the marks scored in the order of subjects namely Physics, Chemistry, Mathematics, Biology, Biotechnology, Computer Science and finally, the over all marks in the Higher Secondary Examination.

Students who are in receipt of any other scholarships are not eligible to apply for Prathibha Scholarship

RENEWAL/CONTINUATION OF FELLOWSHIP

The fellow continues to study Basic Science programmes in school/Junior college/university, and maintains a minimum level of academic performance of first class or 60%(50% for SC/ST/PWD) marks in aggregate or equivalent grade points and has to necesserily pass all the subjects prescribed for the particular academic year (two semesters in case of semester system)and should have obtained the above specified percentage of marks. In the course work in each academic year, the marks/grades will have to be certified by the dean or Head of the institution. The fellowship will be discontinued if the above marks/grade is not obtained. However if the fellow passes all the subjects and obtained greater than 60%(50%for SC/ST/PWD) marks in the subsequent years, the fellowship can be renewed only from that years onwards, again with the condition that the fellow should obtain 60% (50% for SC/ST/PWD) marks in aggregate every year. This is effective from 2012 awardees onwards. The student is eligible to receive the KVPY fellowship upto Pre-PhD level or 5 vears whichever is earlier.

In addition to the above participation and satisfactory performance in the summer camp in the first year and summer project every year thereafter is required for renewal of the fellowship.

KVPY fellows who opt out of the basic science(B.Sc/B.Stat./B.Math./Int M.Sc./M.S) stream at any stage will forfeit the fellowship and contingency grant forthwith. The fellowship for the students slected under the stream SA/SX/SB will be started after the XII standered / (+2) 1 year UG, only if they pursue undergraduate course in Basic Science, that arew B.Sc./B.S/B.Stat. /B.Math./ Inte.M.S.c./M.S in Chemistry, physics, Mathematics, Statistics, Biochemistry , Microbiology, Cell Biology, Ecology, Molecular Biology ,Botany,Zoology, Physiology,Biotechnology, Neurosciences. Bioinformatics, Marine Biology, Geology, Human Biology, Genetics, Biomedical Sciences, Applied physics, Material Science, Environmental Science or Geophysics.

SUMMER PROGRAMME.

Participation and satisfactory performance in the summer programme /project each year from the second year (B.Sc/Integrated M.S) onwards in an academic Institution of national or international repute or DSIR approved research labs (in case of private lab or institutions) is made mandatory for renewal of the Fellowship. The report on the summer programme/project together with the assessment report from the mentor will have to be forwarded along with the course performance certificata for renewal purpose from second year of B.Sc/B.S/B.Math./B.Stat/Integrated M.Sc/Integrated M.S programm.

UGC SCHOLARSHIP

I. POST GRADUATE MERIT SCHOLARSHIP SCHEME FOR UNIVERSITY RANK HOLDERS AT UNDER GRADUATE LEVEL (PG)

The scholarship may be tenable for a period of two years to enable the rank holders of each university at undergraduate level to pursue their Master's Degree. All universities/degree awarding institutions would be required to issue rank certificates to the toppers of the university in B.A., B.Sc., and B.Com. III. POST-MATRIC SCHOLARSHIP FOR STUDENTS BELONGING TO THE MINORITY COMMUNITIES (UG,PG)

VI. UGC JUNIOR RESEARCH FELLOWSHIP (M PHIL.-PH.D)

The Junior Research Fellowship (JRF) scheme of the University Grants Commission (UGC) is open to candidates who qualify in the National Eligibility Test-Junior Research Fellowship(NET-JRF) of the UGC and the UGC-Council of Scientific and Industrial Research (ÚGC-CSIR) joint test. However, please note that these are qualifying tests only and do not bestow a fellowship upon the candidate.

The objective of the JRF scheme is to provide opportunities to NET-JRF qualified candidates to undertake advanced studies and research leading to M.Phil/Ph.D. Degrees in Humanities and Social Sciences including Languages and Sciences.

ELIGIBILITY - Target Group: Candidates who have qualified in NET-JRF or the UGC-CSIR joint tests. Eligibility: Candidates who have qualified in NET-JRF or the UGC-CSIR joint test. However, the registration for the M.Phil/PhD is made by the Universities/Institutions/Colleges within stipulated period of two years from the date of declaration of result or date of issue of award letter/date of joining the fellowship.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the Fellow will be evaluated by experts. If the research work is found satisfactory, his/her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF). In case the work for the first two years is not found satisfactory, an additional year will be given to him/her for improvement. However, during this period he/she will be designated as a Junior Research Fellow. In such cases work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years and there is no further provision of extension.

The Maulana Azad National Fellowship for Minority Students is formulated and funded by Ministry of Minority Affairs. The scheme is open to candidates who belong to one of the Minority Community i.e. Muslim, Sikh, Parsi, Buddhist, Christian & Jain and are pursuing higher studies such as regular and full time M.Phil/Ph.D. degrees in Sciences, Humanities, Social Sciences and Engineering & Technology. The reservation for differently abled students shall be made as per provision laid down by the Government of India

IX. RAJIV GANDHI NATIONAL FELLOWSHIP FOR SC/ST CANDIDATE (M Phil. Ph.D)

The Rajiv Gandhi National Fellowship (RGNF) Scheme for Scheduled Caste and Scheduled Tribes is formulated and funded by Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs. The scheme is open to candidates who belong to Scheduled Caste & Scheduled Tribe and wish to pursue higher studies such as regular and full time M.Phil. and Ph.D degrees in Sciences, Humanities, Social Sciences and Engineering & Technology. There are 2000 slots for Scheduled Caste and 667 slots for Scheduled Tribe candidates every year for all the subjects.

X. SWAMI VIVEKANANDA SINGLE GIRL CHILD SCHOLARSHIP FOR RESEARCH IN SOCIAL SCIENCES (M Phil. Ph.D)
